Just following up Mike's note to the board with one last 2024 board communication of my own:

Thanks – Thanks to everyone for your volunteer work in the last year. 2024 was a very good year for the FSPAC, and with the hazing bill becoming law and the freedom of association bill passing the House, there has never been more evidence of our impact on the policy and political scene.

Legislative Update – President Biden signed the Stop Campus Hazing Act into law on Christmas Eve, so it takes effect in 2025 in various phases. Congrats to everyone on the FSPAC board for working to make this happen, and I can tell you we would not have made it to the finish line without the relationships the FSPAC has built over the years.

Financial Condition – We are at \$497,658 for 2024. We need \$2,342 left to make it to \$500,000 for the year – that's a number we have crossed only once in our existence. We have more than \$17,000 in outstanding pledges for the year – this is the highest amount of unpaid pledges we have ever had at the end of a year. Please help us get \$2,342 more in the door before midnight Tuesday night so we can break \$500k for the year. All unpaid 2024 pledges will be cancelled on 1/1/24.

Board Pledges – A number of board members have not yet made 2025-26 personal pledges. Those are overdue, and I will email you separately. Every board member is required to pledge at least \$250 a year for two years.

Donor Pledges – We do best when you ask for two year pledges in Q1 of 2025 and report them. Please start asking.

2025 20th Anniversary Gala – The Gala is in 96 days. This is one of the shortest timeframes to raise money for a dinner in our history. Please have a plan to come out hot in January.

Officers – Thanks to the officers stepping out of their positions this week. Carole, Donna, Kitty, and David have done great work as our Vice Presidents and are central to why we had such a productive 2024. It has been a great team this year and we will reap the long-term benefits of their efforts in the years ahead.

Incoming Board Members – Starting next week, we will be joined by the following new board members

1. Micaela Isler – Alpha Xi Delta. Micaela is a former FSPAC board member, a former national president of Alpha Xi Delta, and the CEO of the National Association of Business PACs. University of Texas alum.
2. Shannon Campagna – Kappa Delta – Shannon runs her own lobbying firm in DC, has been in-house with companies like Safeway and Mars, and a contract lobbyist for large lobbying firms. She is a proud Alabama alum.
3. Elizabeth MeLampy – Alpha Phi (replacing departing member Allie Winkelman) – Elizabeth is a double Harvard grad and is a litigation fellow with the Natural Resources Defense Council

In addition, we have two men we expect to join the board in January, but they are not active donors to the FSPAC and cannot join the board until they become donors. We are in the process of recruiting several other board members.

Thank you to those who have been praying for Patty and our family, and to the many outpourings of support from FSPAC board members. Leslie Williams is with us several times a week, and we see Julie Burkhard regularly, and items from many of you are present with us every day here in Atlanta.

Hope everyone had a great start to Christmas and Hannukah, and best wishes to you and your family for an amazing 2025. Our best FSPAC year is ahead of us and I look forward to working with you to make it so.
