Hotel Rooms for April – Room Block is Filling Fast

The FSPAC is committed to a portion of the FGRC room block for Hill Visits/PAC dinner in April...we will be on the hook for several thousand dollars in expenses if we do not fill our portion of rooms so please book here before you book elsewhere.

A block of rooms has been reserved at the Omni Shoreham at the discounted rate of \$309/night plus taxes and fees. Rooms can be reserved using this link or by calling the hotel at 202-234-0700 and referencing the FGRC Hill Visits program. Reservations within the block are first come, first serve. The discounted rate will end on March 10 but the block may fill before that time because we estimated the number of rooms needed based on prior year practices of two students to a room. Women's Breakfast Wednesday, April 2

The PAC will host a breakfast for students and alumnae in town to lobby, and the breakfast will feature multiple female members of Congress. This event was well-attended and well-received in 2024 so we will do it again. The breakfast seats are earned in groups of two: 1 student/1 alum at a time and it is open to groups that have raised \$5,000 cash in hand for 2025 or \$10,000 in pledges for the cycle (for sororities with 1 board member) OR \$7,500 in cash or \$12,500 in pledges for the cycle (for sororities with 2-4 board members). The deadline to meet those goals is Friday, March 28.

This event will be open only to women's organizations actively raising money for FSPAC.
