3. If you have a Student who wants to be a Student Speaker at the Dinner, TODAY at midnight is the deadline to apply. They must send Kevin a video of their speech – max 5 minutes – and a separate email to make sure I know they sent it and it is not caught in a spam filter.
4. Donor Recognition – We are trying to get 5, 10, 15, 20 year donor rolls right and need your help. You were sent this two weeks ago and we have made every change a board member has asked for...our hopes for making sure we get YOUR donors recognized right rests on YOU responding to that email by Monday (that's an extension from today's original deadline). 90% of board members have not yet responded to this email.
5. Work with Betty Quick to be responsive to her request for info on your dinner seats at the Gala.
6. Attend the Monday FSPAC Board meeting at 8 pm.
